Department of Humanitarian Assistance

Al Islah Center has been actively engaged in disaster and humanitarian activities since 2002, our work became especially prominent during the 2005 earthquake, where we delivered effective relief services and established a well-equipped shelter home for orphan children in Mansehra, providing all essential facilities in line with our mission.

In the following years, Al Islah Center continued its humanitarian role, including extensive support during the 2010 floods and to the Swat IDPs, where we provided timely and well-organized assistance.

In 2024, we formally launched the Humanitarian & Disaster Management Department to streamline and expand our humanitarian initiatives. This year With the generous support of our donors and volunteers, we successfully delivered the following services in the districts of Buner, Swat, and Shangla:

- **365 food packages distributed In Bunir Flood at Bunir**
- **Medical treatment and medicines are provided to 1,767 individuals at Bunir Swat and Shangla.**
- **Wheelchairs distributed to persons with disabilities From Many Districts.**
- **35 Ramadan food packages delivered to needy families**
- **Qurbani meat distribution to approximately 110 families in 2025**

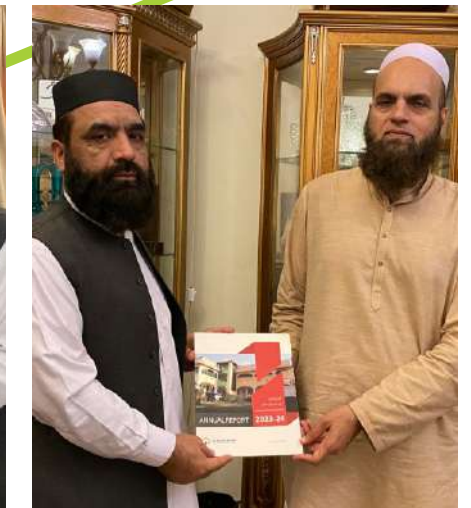
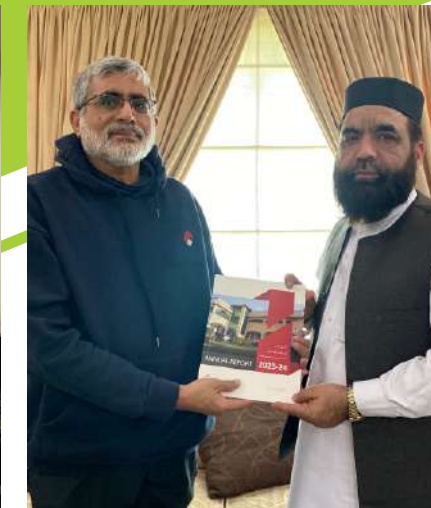

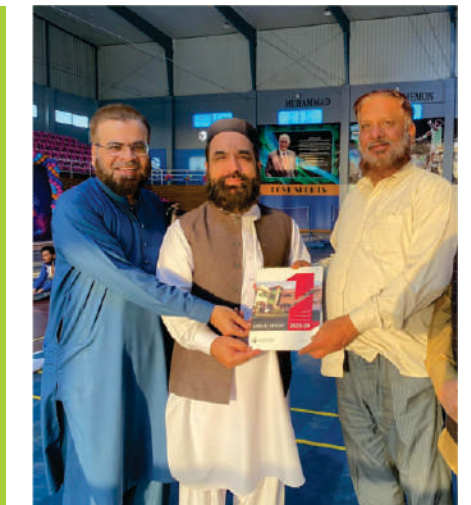

My name is Muhammad Uzair. From a very young age, life presented me with challenges that most children could hardly imagine. My father passed away when I was still very small, and soon after, circumstances led to my separation from my relatives. These early experiences left me in a vulnerable position, yet they also shaped the resilience and determination that would define my journey ahead.

I was admitted to Al Islah Center, a place that became more than just a home for me—it became a nurturing family that took care of every aspect of my life. From my smallest needs, my daily routine, to my education and spiritual growth, the center provided me with guidance, care, and love. They ensured that I had the opportunity to learn, grow, and build a foundation for my future, instilling in me values of discipline, compassion, and faith.

At Al Islah Center, I immersed myself in Islamic education. I memorized the entire Holy Quran (Hifz) and studied its translation to deeply understand its meanings and teachings. I also participated in the Rabit-ul-Madaris Hifz examinations, where I achieved full marks—100 out of 100 in the known exam, a testament to my dedication and the guidance I received. My heart was drawn to the beautiful recitation of the Quran, and my dedication bore fruit when I earned first place at the district level in the Quran competition organized by the annual Madaris Bazm-e-Quran. My fascination with technology and computer science has been boundless. I am naturally curious, always eager to explore, learn, and understand how software, systems, and innovations shape our world. This passion led me to pursue a bachelor's degree in computer science (BSCS) in Karachi, with the support and encouragement of Al Islah Center and Techwards, a well-known and respected software company in Karachi. Alongside my studies, I began interning at Techwards, where I have been able to apply my skills in real-world projects and continue my journey as a budding software engineer.

Today, I am a full-stack front-end developer, steadily progressing in my third semester. My academic journey has been marked by excellence, achieving a 4.0 GPA in the first semester and a 3.96 GPA in the second semester, reflecting my dedication, hard work, and continuous pursuit of knowledge.

Beyond academics and professional skills, my mindset and heart remain deeply rooted in Islamic values. I sincerely aspire that Allah continues to polish my character, bless my efforts, and guide me to use my knowledge and skills in a way that serves the religion of Allah and benefits humanity. Report on the Audit of Financial Statements

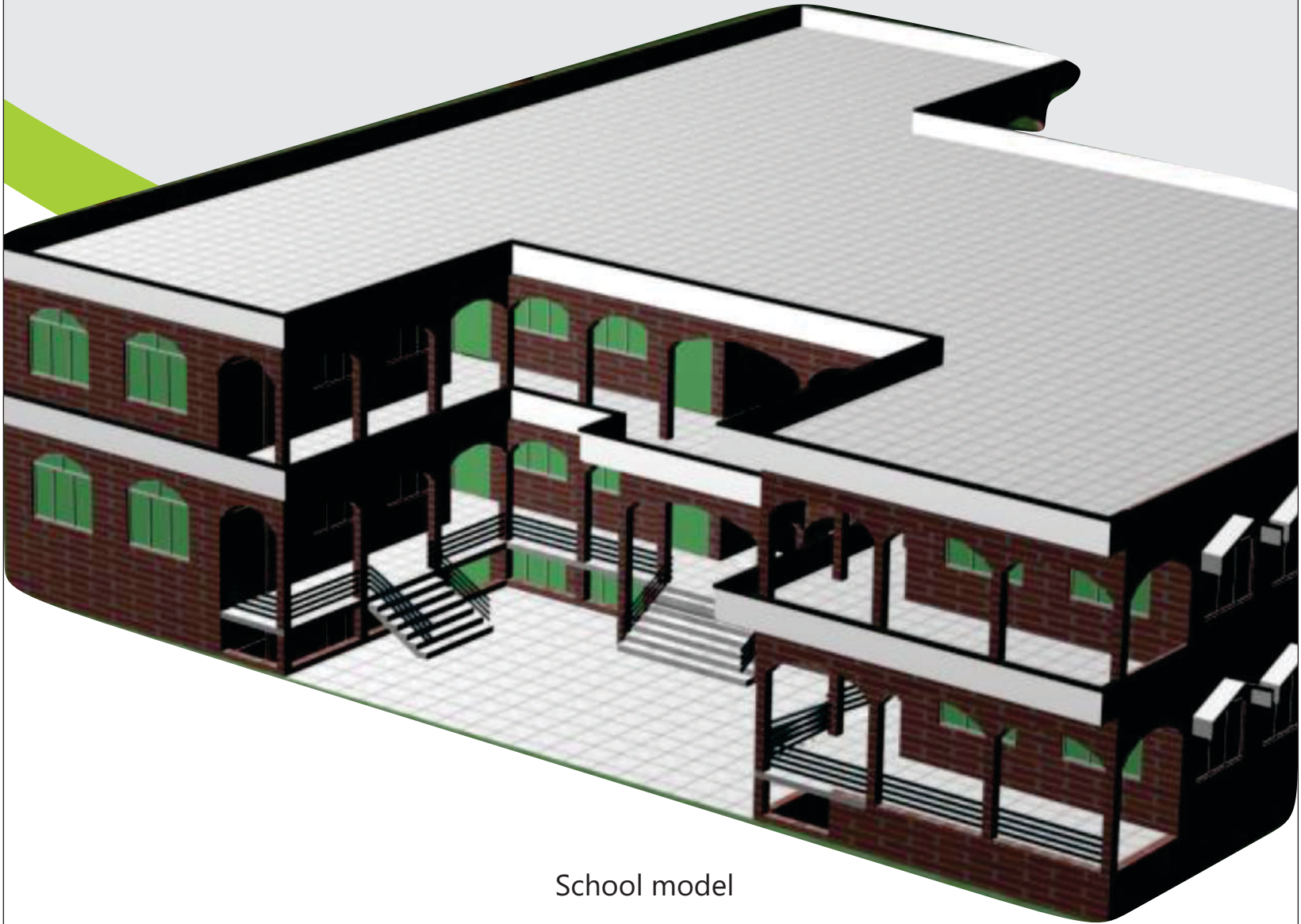
